The DCGuard is a directional, fault current suppressor based on current interruption by switching of IGBT transistors. This type approval is applicable for a directional and bi-directional peer-to-peer configuration.

The device is used for fault current suppression and does not replace circuit breakers or switches for isolation. The system design of a specific application needs to be approved on a case

by case basis.

- 4. aR fuse and di/dt filter are not included in this type approval certificate.
- 5. To ensure safe disconnection of the VACON DCGuard, a mechanical disconnector is required in front of each VACON DCGuard.
