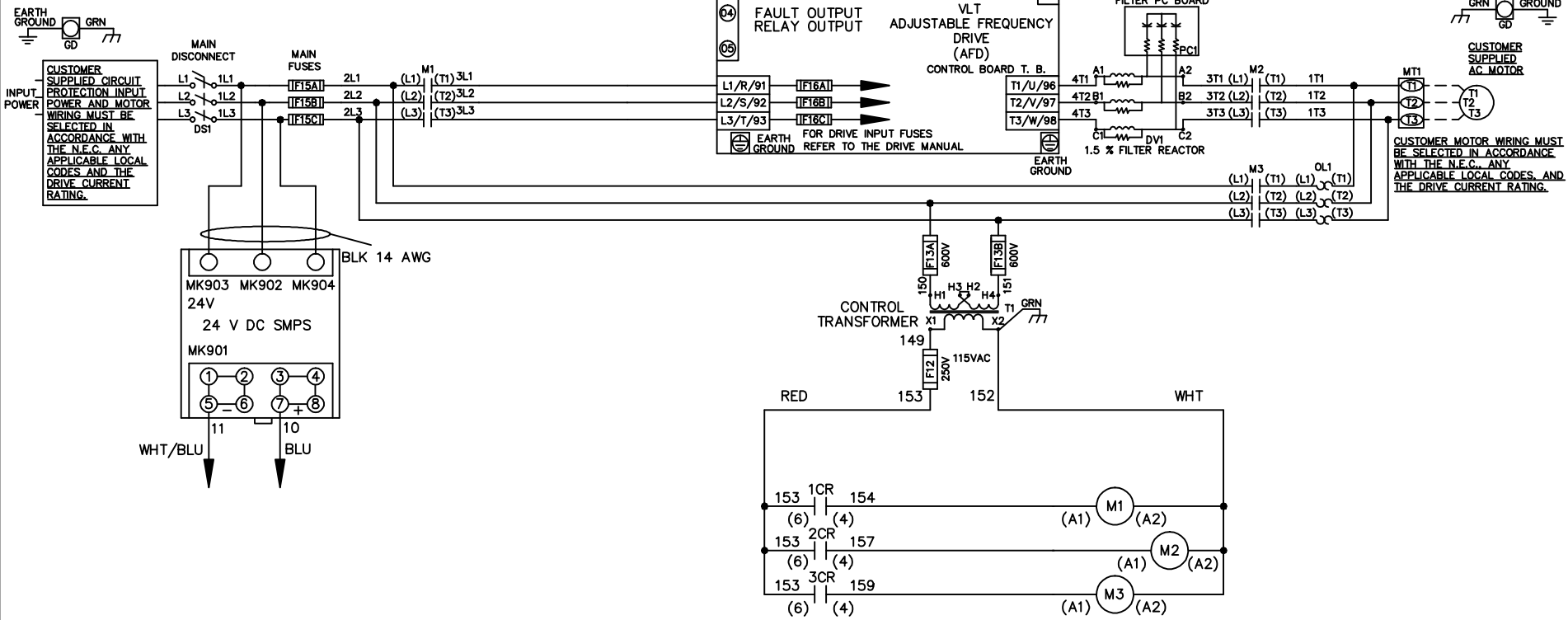


WIRE COLOR SCHEME
